ON the 13/09/18 we escorted a convoy of 02 x OUV and 02 x LOW COADERS from KC2 through Mandai rd into BKECKSE) exited UPP JUFONG RD to make a loop through Pioneer rd north to enter back into PIECKSE). Convoy movement was very smooth throughout. Before the convoy reached the slip road me and one junior LCP 2UFPLAS on CMP19) punch forward as our job was to taper of lane 4 of the expressway and direct traffic to lane 1, 2 and 3 which we entered was possible. Around 1443 HRS I on CMP30) was at the Chevron supervising the junior and also assisted him in slowing down the vehicles from lane 4. I saw a lorry (YP7054T) saw us and slowed down and was coming to a stop. Me and my junior then inched out into lane 4 as the convoy was approaching us. I looked to my back as I pressed my horn to warn the driver to stop with my siren and blinker on. I also waved at him but when I looked at the driver I saw him picked up speed and tried to cut me on my right. Seeing that I tried to immediately moved off but to no avail. So I just jumped off my bike and landed on my back. I suffered contusion of my left calf and also multiple contusions on my back. Incident happened on lane 4 of the expressway before STANIS BAHAR exit on PIECKSE).

I then stopped my vehicle at the chevron as I wanted to taper traffic on the 4th lane of the expressway. I noticed that a lorry driver, YP7054T slowed down so I moved my vehicle slowly into the left lane so that I could stop traffic on the 4th lane. We ensured that traffic on 3 lanes are passable. When I looked back again, the lorry was suddenly close to
