<p>DECLARATION</p>		
<p>On the 18 Oct 2018, at about 3.50pm, I was driving along Hill Street turning left into Stamford Road. The traffic light turned green and I went straight through the red light of the road. However, he was still stationary and I was slightly hit the back of the taxi. I came down and spoke to him and checked. He claimed that his taxi hornet is unable to open. However when I tried, the button was still functioning and I could open the hornet and close it back without any trouble. He then insisted on taking a copy of my IC & driving license, which I gave and asked for his in return. We both checked and confirmed that there was no other damage to his taxi and my car. The driver is also fine as per photo taken and he did not complain of any discomfort. No other parties were involved and no one was injured. We managed to contact the driver and he managed to send to the Transcar Workshop and the estimated repair cost is \$41000+ due to the lost assignment. We were dropped as he also wanted to claim for loss in income and rental fee. This was too high for a small and minor knock.</p>



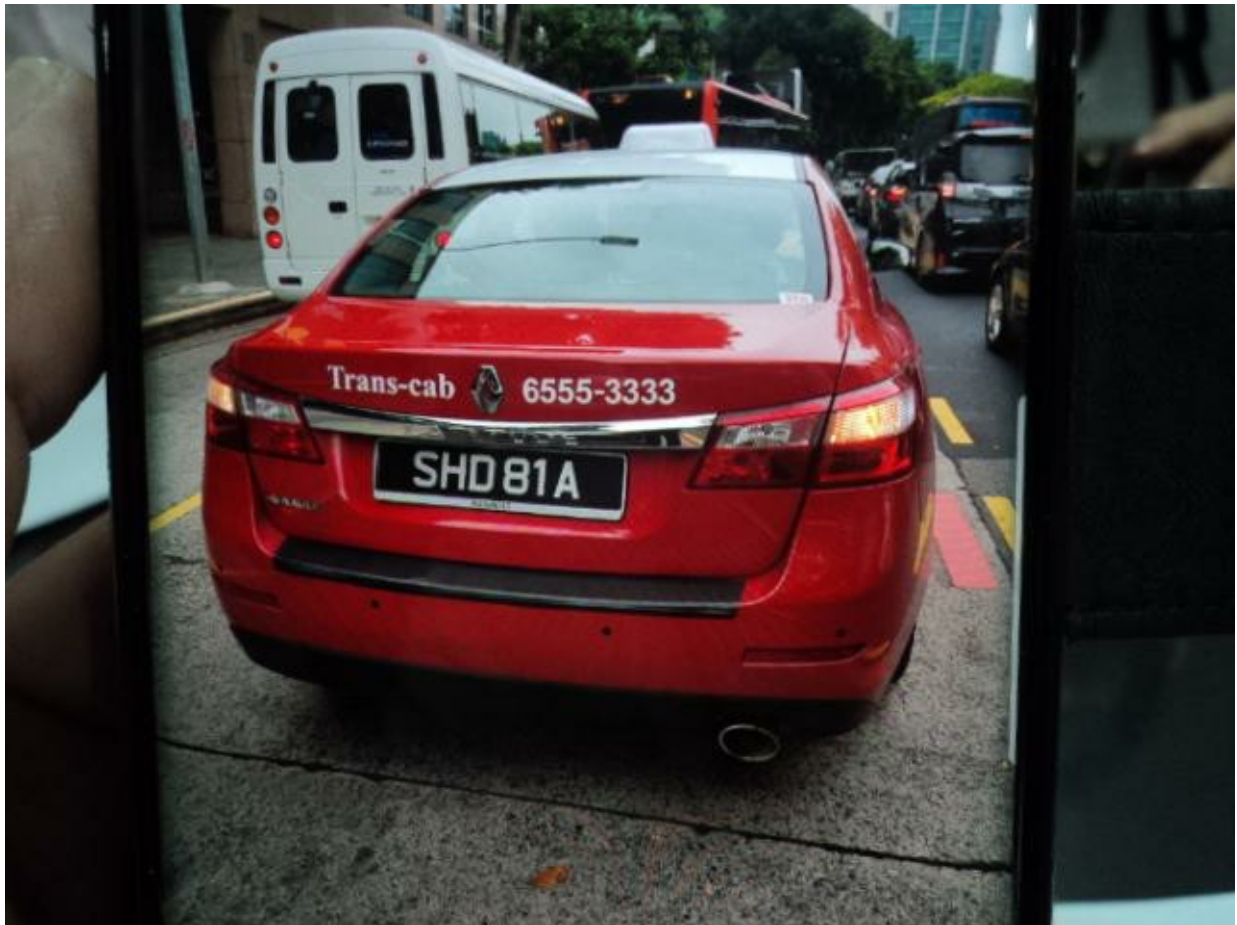
