#### Circumstances of Accident

#straightroad, Changing lane & Moving in own Lane, Blue Car SGX8497M, White Car SLP1108R. The accident took place at around 7.42pm on 22 October 2018. It happened before the right turn from Upper Aljunied Road into Joo Seng Road. I was driving along Upper Aljunied Road towards Upper Serangoon Road and was on the outer lane. I was behind a lorry which had stopped in front of me waiting to make a right turn into Joo Seng Road. I signaled left as I intended to filter out onto the left lane. I checked my left mirror and then turned my head to verify if there was any car next to me on my left. Having checked that there was no vehicle I turned out left and then a BMW rammed past my car. The BMW vehicle number is SLP1108R and the driver is Zhang Weijian (Blue IC No. S2747991Z). We got down from our cars respectively and checked the car damages and took photographs. The other driver informed me that he wanted to call the police and I have no objection. He called the police and after both of us had taken turns to speak to the police using his phone the police informed us separately that as there were no injuries and no damages to public property the police will not take the case and that we should inform our respective insurance companies. After hanging up the phone with the police we took photos of each other's IC and exchanged hand phone numbers and then we left the scene.

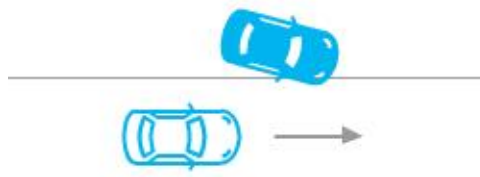

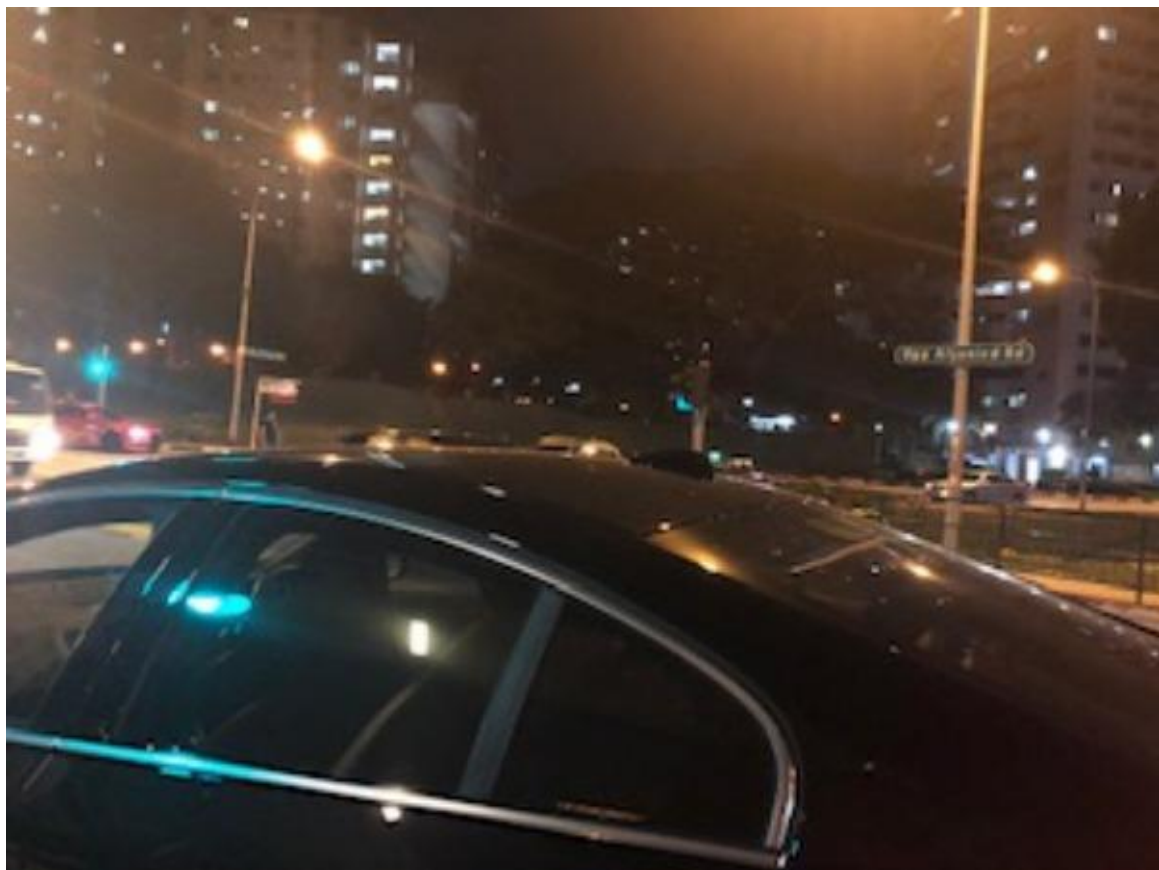
