REFER TO POLICE REPORT - T/20181020/2081 On the 19th of October 2018 at about 2345 hours, I was driving a female passenger to Blk 628 Hougang Ave 8. I was driving a maroon coloured SMRT taxi SHB577Y. The passenger asked me to stop her along Hougang Ave 2 as the main road was just beside the said block and as such, I stopped my taxi by the side of the road along Hougang Ave 2, directly below a lamppost. She paid for her taxi, causing my taxi to move forward. Both me and my passenger were still inside the taxi. I then stepped out of my taxi and saw that a silver coloured BMW car bearing the plate number SLG7272G had crashed into the rear of my taxi. The driver of the BMW car then came over to me and kept apologizing and asked me not to report the matter. I wish to state that at that point of time, the driver smelled strongly of alcohol. A witness of the accident then called for ambulance and traffic police as both me and my passenger were dizzy due to the accident. I wish to state that no one was conveyed to hospital and that there are no visible injuries and all the parties involved. The traffic police officer then provided a case card bearing the report number F/20181020/0005. Me and my passenger are not injured due to the accident. The rear of my taxi is completely dented inwards whereas the front portion of the BMW car is also dented. My passenger is one Haliza (HP: 93219687) whereas the witness of the accident who helped me call for the police is one Tan Aik Tiong (HP: 98273220).
