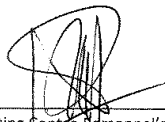

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

19 Oct 2018 approximately 10pm, I was driving towards Singapore Immigration along AYE TUA S to exit Singapore. ~~The jam~~ There was jam and vehicles were driving slowly. I drove too near to vehicle SJP261K but did not hit the vehicle. The lady sitting at the back seat of his car turned to look at my car (too close) and spoke to the driver around 3 to 4 times. A few minutes later, the male driver came out and asked me to reverse the vehicle before taking picture of my car and my driving license. I was very sure I did not hit his car. Otherwise he wouldn't take a few minutes chatting with the lady behind before coming out of his car and he wouldn't ask me to reverse the car before taking picture. The next day, he messaged and asked for SGD300 cash for scratches that were not caused by me.

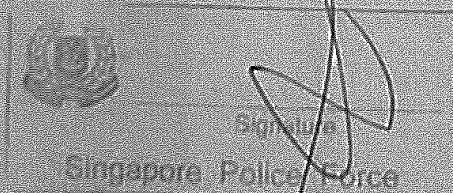
