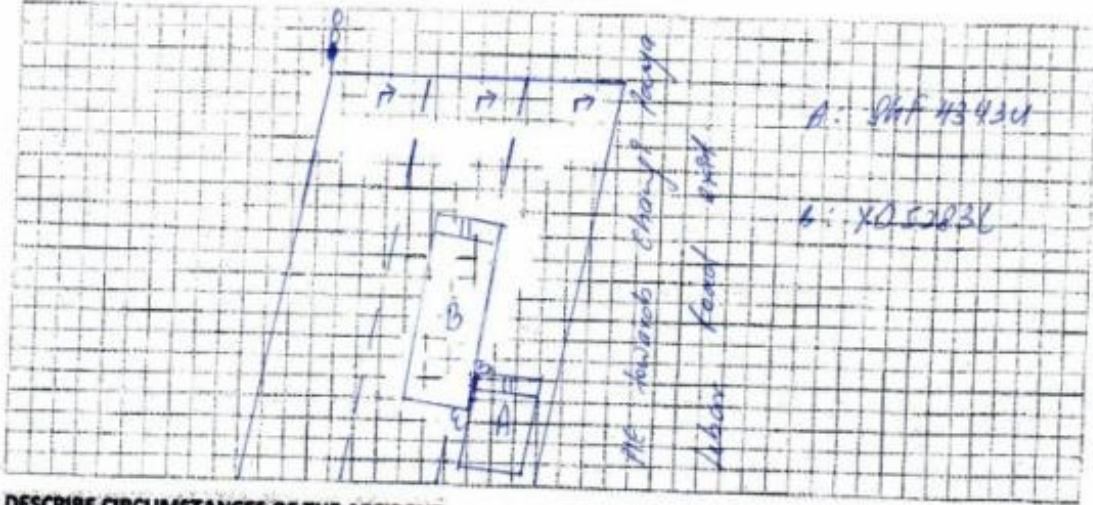

**DESCRIBE CIRCUMSTANCES OF THE ACCIDENT**

I was travelling straight along Rte towards Changi  
Jaya Lebar Road Exit. I was stationary as the  
traffic light was red. When the traffic light turn  
green, the vehicles in front of me moved off. I notice  
that vehicle (B) who was travelling on the lane  
to my left had his signal on with the intention  
to cut into my lane. Hence I continue to stay stationary

about to complete the change of lane, I saw that his  
was too close. It happened too fast, hence I was unable  
to sound my horn and he collided onto me.
