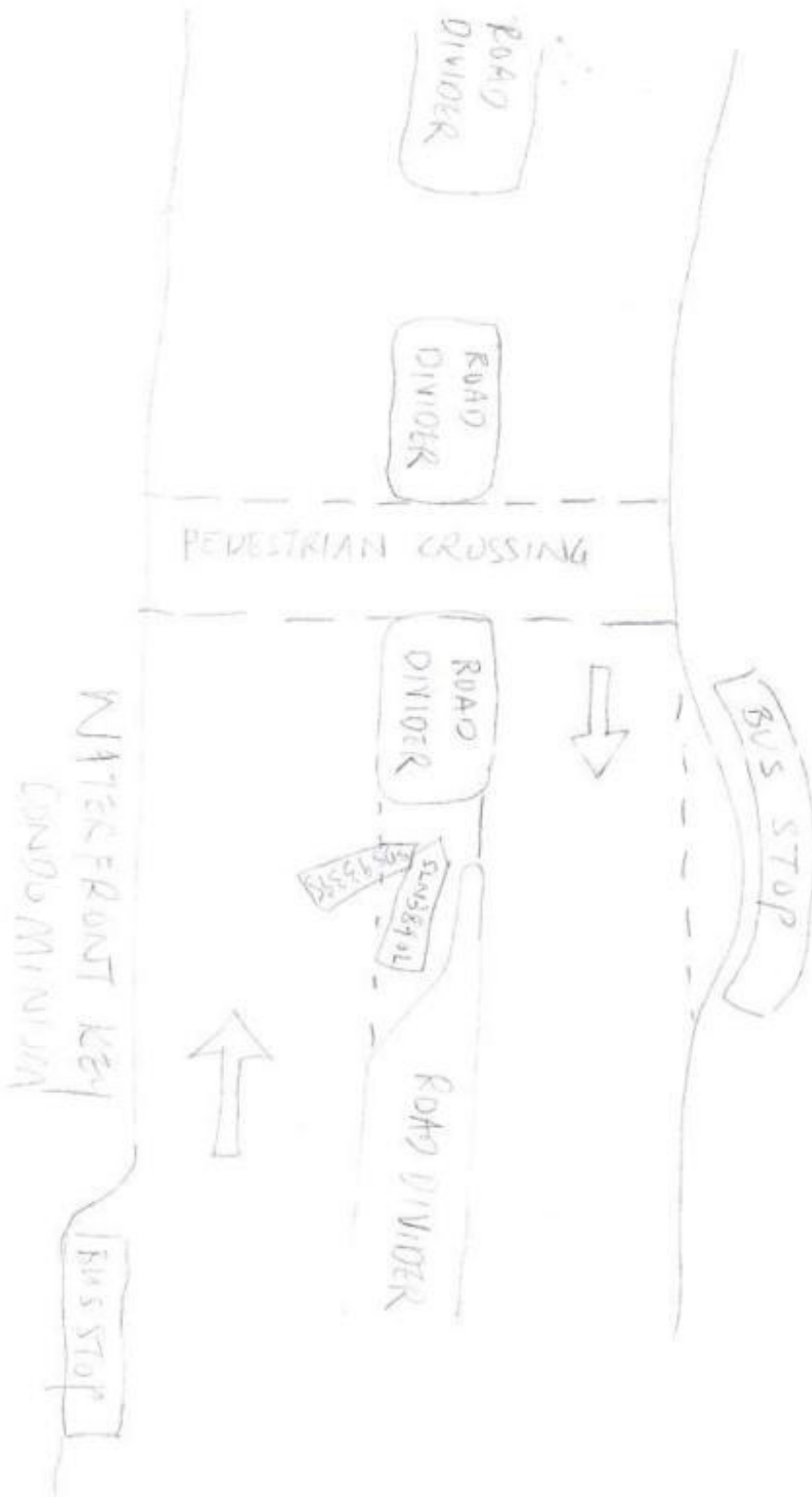

Accident 27 Oct 2018 Bedok Reservoir Road

On 27 Oct 2018 at approximately 13:25hrs, I was driving in the right lane of a 2-lane road along Bedok Reservoir Road heading in the direction towards Kaki Bukit. Somewhere near Waterfront Key condominium, I steered my vehicle (SLN3890L) into a U-turn slip lane on the right. At that time, the traffic light just ahead of the U-turn junction was red, and all vehicles along that stretch of Bedok Reservoir Road were stationary in both directions.

When I eased my vehicle into the U-turn slip lane on the right, the slip lane was clear and there was no vehicle occupying the lane ahead of me. Just as I shifted my focus to check for oncoming traffic approaching from the opposite direction, I heard an sudden impact to the left side of my vehicle. Subsequent review of the video footages captured by my in-vehicle cameras revealed that vehicle (SDS9339S), which had originally been stationary in the lane adjacent to the U-turn slip lane, had failed to maintain a proper lookout for my moving vehicle in the slip lane, and swerved abruptly into the straight path of my vehicle (from the adjacent non-turning lane) and hit the left side of my vehicle.

Due to the abrupt nature of the incident, my wife who was in our vehicle (seated left rear) during the accident, had mistakenly assumed that I had caused the accident. Acting out of good faith, I did not think to question her or to check the in-vehicle camera video footages, and handed \$100 to the driver of SDS9339S at his request. It was only after we had left the scene that my wife clarified that she in fact had not witnessed the events of the collision. At the time of collision, she had been looking at her mobile phone and had simply assumed that I was responsible for the collision without checking the in-vehicle video footage. I have decided to include this matter in the report as I feel that the driver of vehicle SDS9339S had not acted honestly and honorably, and had taken advantage of our good faith.

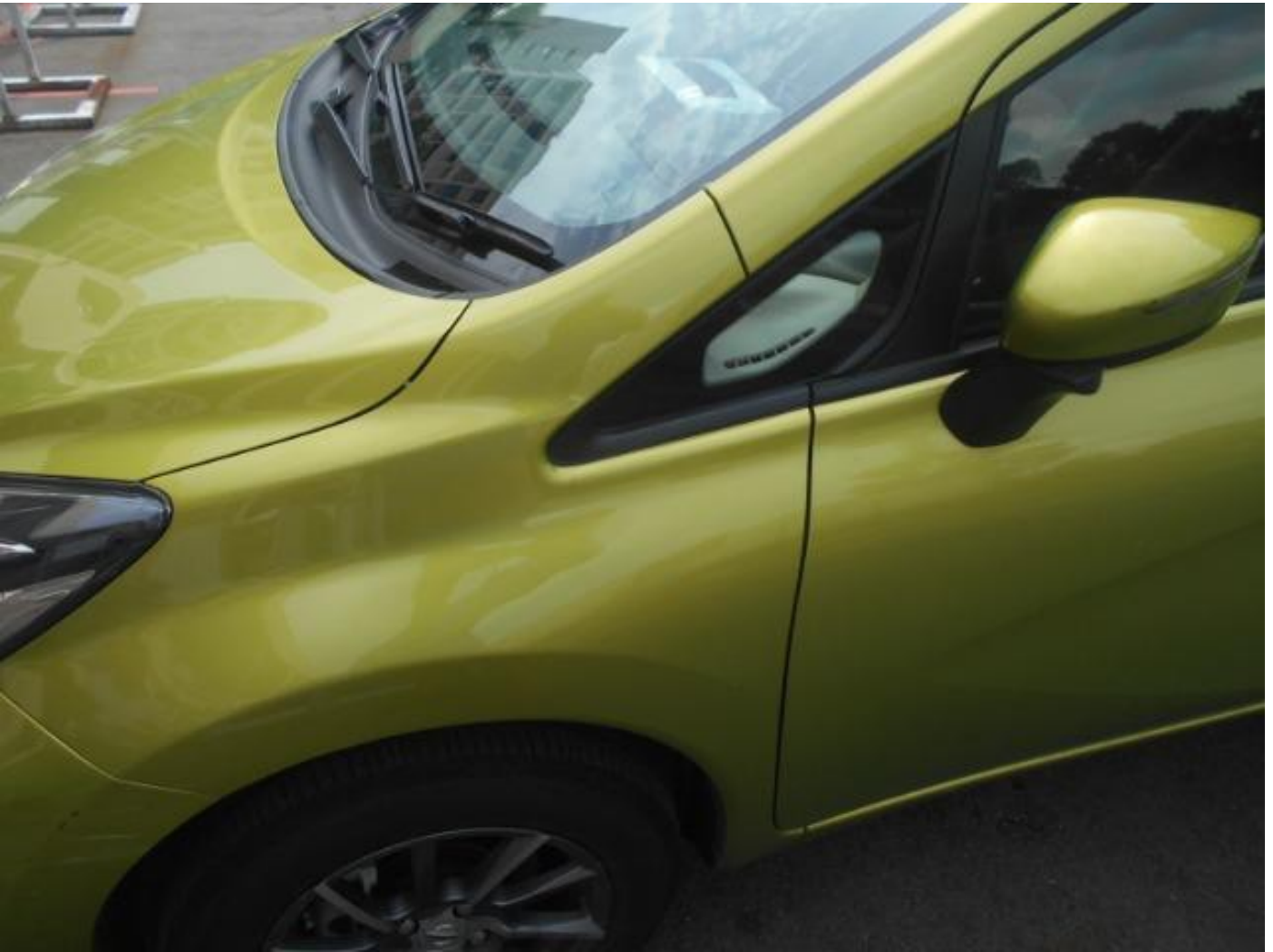
