VEHICLE LEASE AGREEMENT "TOYOTA HIACE 13 SEATER HIGH ROOF"

LEASE AGREEMENT

This lease agreement is made between GOJALANJALAN TRANSPORT PTE LTD, whose business registration number 201722971H (hereinafter referred to as "Lessor") and RED DOT EXPRESS PTE LTD (hereinafter referred to as "Lessee").

This lease is for a term of 5 days beginning on the date of 26th Oct 2018.

PURPOSE

Lessor hereby leases to Lessee the Vehicle and vehicle detail as described in Appendix A, attached.

Lessee shall pay security deposit SGD 0 payable in advance upon confirmation.

Rental amounting to SGD 250 per day shall be paid in advance before collection of vehicle.

5. SECURITY DEPOSIT

The total of the above deposit shall secure compliance with the terms and conditions of this agreement. The lessor reserves the rights to deduct the unpaid rent and other damage cost under the terms of this agreement.

LATE CHARGE

A late fee of 1.5% per month on the monthly rent shall be added if any payment of rent made after the due date.

If the lessee fails to make payment, the lessor may terminate this Lease and Lessee's rights to possess the Vehicles; take possession of the Vehicle by any peaceable method or manner permitted by law, with or without court action. The lessee shall make payment immediately for the cost and expenses incurred.

8. TERMS AND CONDITIONS

- Rates include road tax, periodical maintenance, annual ROV inspection and reasonable repair work only.
- If no invoice for the periodical maintenance and repair expenses is received, no liability shall be incurred. Billing name should be 'GOJALANJALAN TRANSPORT PTE LTD'.
- 8.3 Rates also include insurance but the Lessee is responsible for both the insurance excess liability of damage to the vehicle as well as Third Party claims for each and every accident. No free replacement for vehicle under repairs
- Insurance coverage is against liability for the death or bodily injuries to third Parties or for damage to third party property. The lessee is responsible for the FULL damage of the vehicle during the rental period. This includes excess of \$2500 for section 1 and \$3000 for section 2. Insurance does not cover the incorrect use of fuel. The lessee will be responsible for any associated costs.
- The lessee is liable for the cost to replace keys, which have been lost, or the cost of retrieval of keys, which 8.6
- Tyres and excessive wear and tear expenses shall be borne by the lessee himself/ herself.
- Diesel; the vehicle is supplied with a FULL tank of unleaded Diesel which must be refilled at the lessee's expense on return, failing which an estimated refueling charge shall apply. Vehicle quoted is strictly for Singapore use only.
- The lessee must produce copies of valid Driving Licence and Bus Vocational Licence.
