I would like to get a **quotation** from your company for an expert opinion report on one Comfort Delgro taxi that was involved in a case of Causing Death by Rash Act, under Section 304A of the Penal Code, Chapter 224. This is with reference to Police report D/20180915/0154. Please note that this is an **urgent request** and please also do **provide an estimated timeline to complete the expert report**.

Facts of case

Briefly, on the 15th September 2018 at about 11.30pm the Police was alerted on a case of male person lying on the road. It was later established that the male person had jumped or fell out from the taxi when the taxi was on the move. The male person was subsequently conveyed to the hospital was subsequently pronounced dead due to head injury. The taxi driver was subsequently arrested for the mentioned offence as his account of the incident was inconsistent whereby on the first interview, he mentioned that he had alighted the passenger from his taxi. But further investigation revealed that the male passenger had jumped/fell out of the taxi.

Details required in the expert report

- i. If the locking mechanism of the doors are faulty, whereby the deceased had lean on the door and the door gave way/ open.
- ii. If the driver could remotely open/close the doors,
- iii. To check if the brake and accelerator pads are faulty.
