

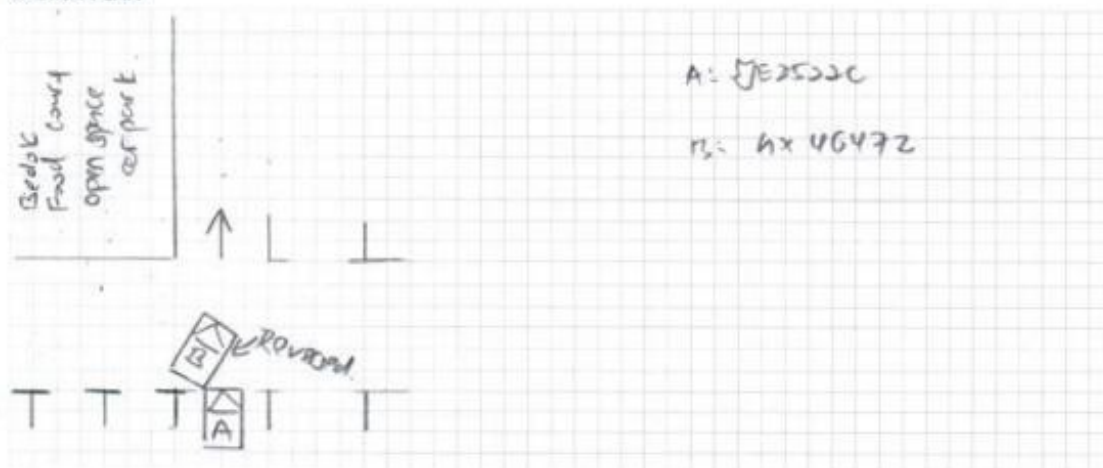

Brief Details.

On the 30/10/2018 at about 1330 hours, I came back to my car bearing the registration plate number SJE2522C which was parked at the open car park of Bedok Food Court (Singapore 469572). I noticed that there was a dent and some scratches on the left side of the front bumper of my car.

Subsequently, I noticed that there was a note placed on my car which mentioned that a vehicle bearing the registration plate number GX4647Z, had collided into my car and drove off. Upon seeing this, I immediately made a check on my in car camera footage and it captured a lorry hitting my car while it was reversing. The accident took place at about 1247 hours as to what was stated in camera footage.

I am unsure of the lot number where I had parked my car but it was near to the entrance of the open car park. I last saw my car with everything in good condition on the same day at about 1230 hours.
