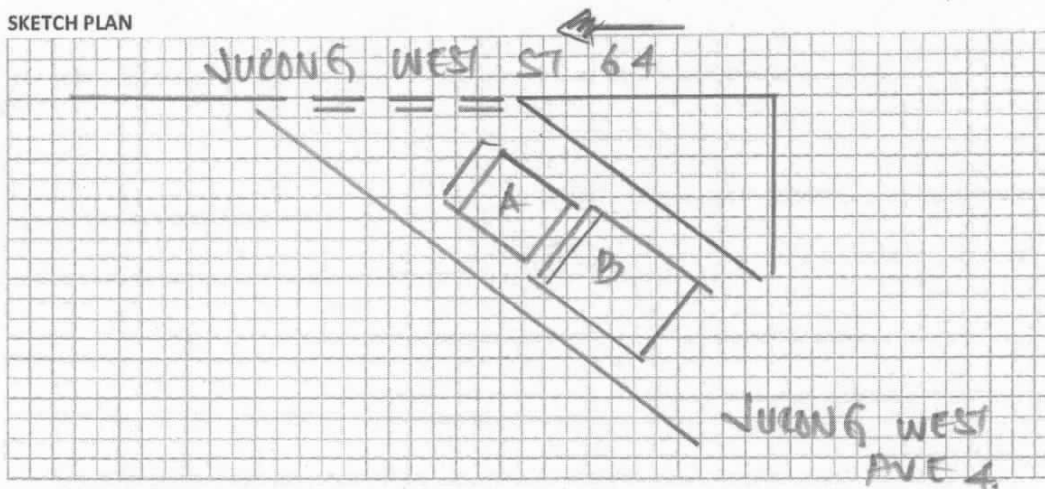

Sketch Plan Pg. 2

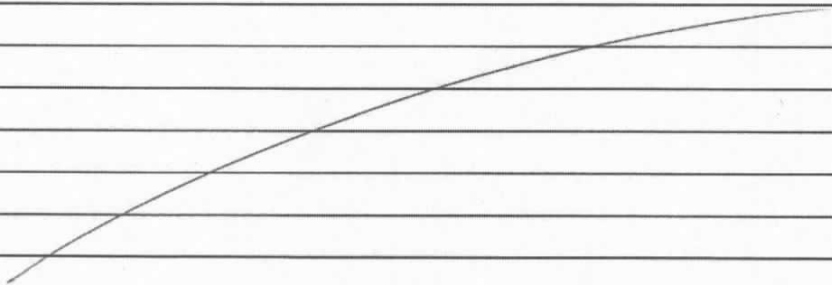
SKETCH PLAN

Describe Circumstance of the Accident.

ON 28/10/2018 @ 0815HRS, I WAS DRIVING MY TAXI (SHC 6223 Z), TRAVELLING ALONG THE SLIP ROAD OF JURONG WEST AVE 4 INTO JURONG WEST ST 64 WITH A PASSENGER ONBOARD.

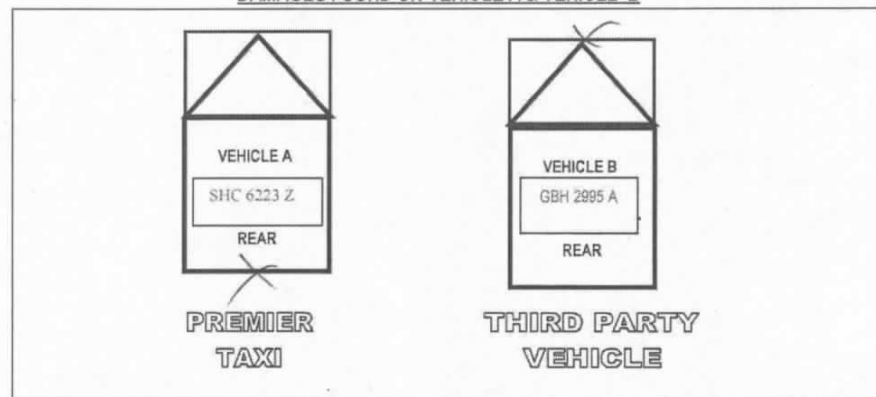

DAMAGES FOUND ON VEHICLE A & VEHICLE B

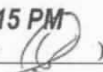
