



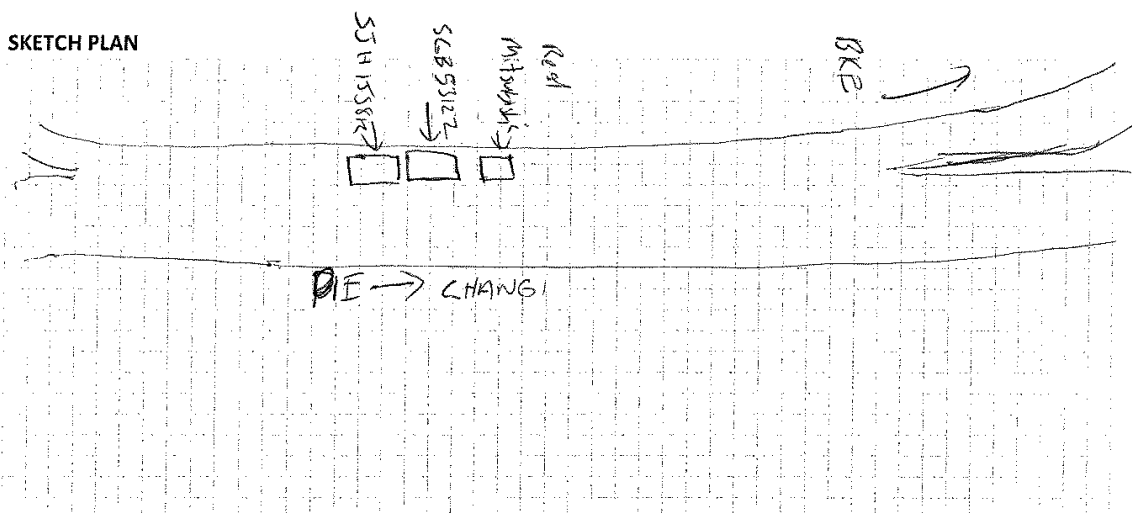

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

At about 7-10 pm on 30 Oct 18, vehicle number SJH 1558R, a Toyota Vios, driven by Mr. Tan Meng Loay, NRIC 7337259C, and the vehicle ^{SGB 5312} ~~was~~, Vickeneshwaran s/o Thangavelu, NRIC 6943921H was driving, a BMW 116, had an accident.


The accident occurred on the PIE about 300 metres before the entrance of the BKE entrance. It had rained and the road was wet. There was a long line of vehicles that were queued up to enter the entrance into the BKE. I was part of the line of vehicles. The traffic was heavy but the vehicles ahead of me were accelerating to amped speed.

A red Mitsubishi i that was directly ahead of me suddenly applied brakes as the cars ahead were also braking. I had to apply e-brake as the Mitsubishi stopped so suddenly, presumably because it was too close to the car in front of it. It is important to note that this same vehicle had previously rashly cut into my lane as it exited the Clementi exit and entered the PIE. It was driving quite fast. This was also corroborated by Mr. Tan, the driver of the Toyota Vios.


After I applied e-brake my car came to a stop after skidding about a meter or more. I stopped barely short of the Mitsubishi. The vehicle behind had braked and I could hear it skid. It could not stop in time and hit the rear of my car. Both the driver of the Toyota and myself stopped by the road shoulder. The Mitsubishi drove away. Mr. Tan apologised for the accident and accepted it was his mistake, as his car could not stop in time. Upon inspecting my car, the rear bumper was damaged. Mr. Tan and I exchanged particulars, took photos of the incident and then drove off.

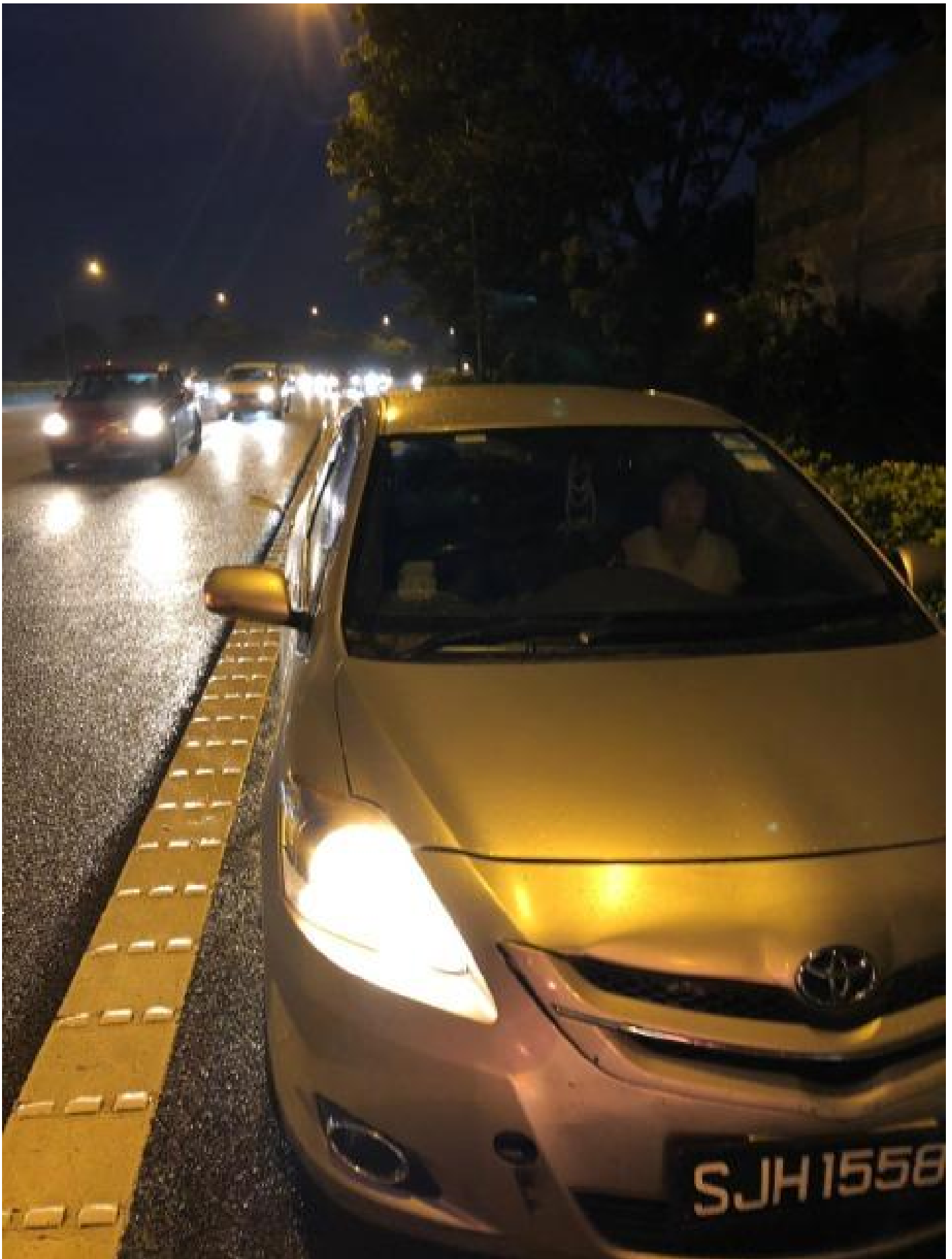
