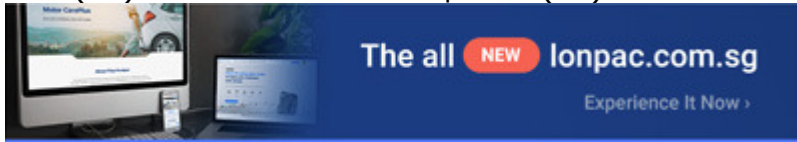

Kindly look into his case.

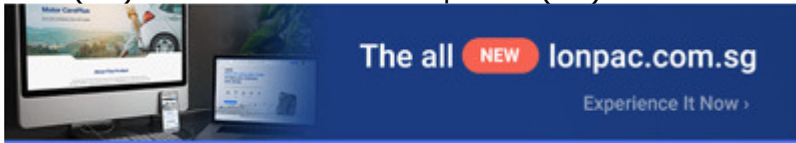
