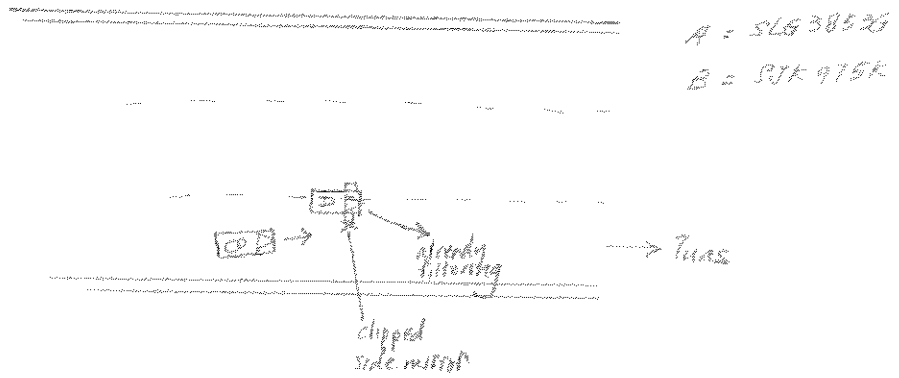

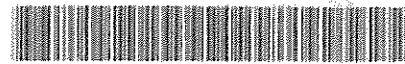

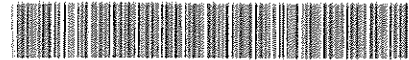
Brief Details.

On the 20/10/2018 ta about 0920hrs, I was driving my car SLG3853G on AYE towards Tuas before exit to Jurong Town Hall. There were three lanes and I was driving on the middle lane. My wife was sitting at the front passenger seat while my kid was sitting behind. I checked my right side and it was clear so I filtered to the right most lane. As my car was already more then half way in the lane, suddenly this car SJK975K squeezed through from my right and continued to went past my car. At the point of time I did not realised the said car had hit my right side mirror. On the 28/10/2018 I received a letter from Liberty Insurance where the said car owner of SJK975K was claiming damages from me. I checked my car and discovered that there are scratches on the right side mirror. I viewed my back in-car camera and it showed that I have already filtered more than half of my car into the lane when this car SJK975K sped up from behind and squeezed through from my right. From the camera it clearly showed the said car was almost touching the right shoulder of the road. I have the footage as proof for the investigation. That is all.
