Brief Details.

On 30/10/2018 at about 1947hrs, I was driving in V1(SKE3846A) on the extreme right lane along BKE towards Bukit panjang.

While I was driving straight, vehicle ahead of me with the Registration plate number bearing SHC3676U suddenly applied Emergency brake.

Therefore I immediately applied brake to avoid Collision with the vehicle ahead. I managed to avoid collided onto the vehicle ahead however the vehicle behind of me V2(SKA9112R), V3(SLL6422X) and V4 (SMA1747M) concurrently collided onto the rear of my vehicle resulting into a 4 car chain Collision.

After the accident, all of us then exited our vehicle and exchanged our particular before leaving the vicinity. No one was observed to be injured and no one was being conveyed by ambulance.

However, my passenger on the vehicle V1 informed that she suffered some strain on her neck. Thus I am lodging this report for record purpose.

I wish to state that on the same lane ahead, there were an traffic accident involving 2 more vehicle with registration plate number bearing SKZ8020Y and JGU9220.
