THE DRIVER OF CAR B REFUSED TO GIVEWAY AND I REFUSED TO GIVEWAY AS I HAVE THE RIGHT OF WAY. THE WORKERS THEN TRIED TO MOVE THE BARRIERS ASIDE FOR ME TO DRIVE PAST AND I DROVE SLIGHTLY INTO THE LAST LANE AND STOPPED, THE DRIVER OF CAR B JUST DROVE THERE UPON SEEING AND GAP BUT GLAZED INTO THE RIGHT REAR CORNER OF MY CAR WHILE DOING SO.

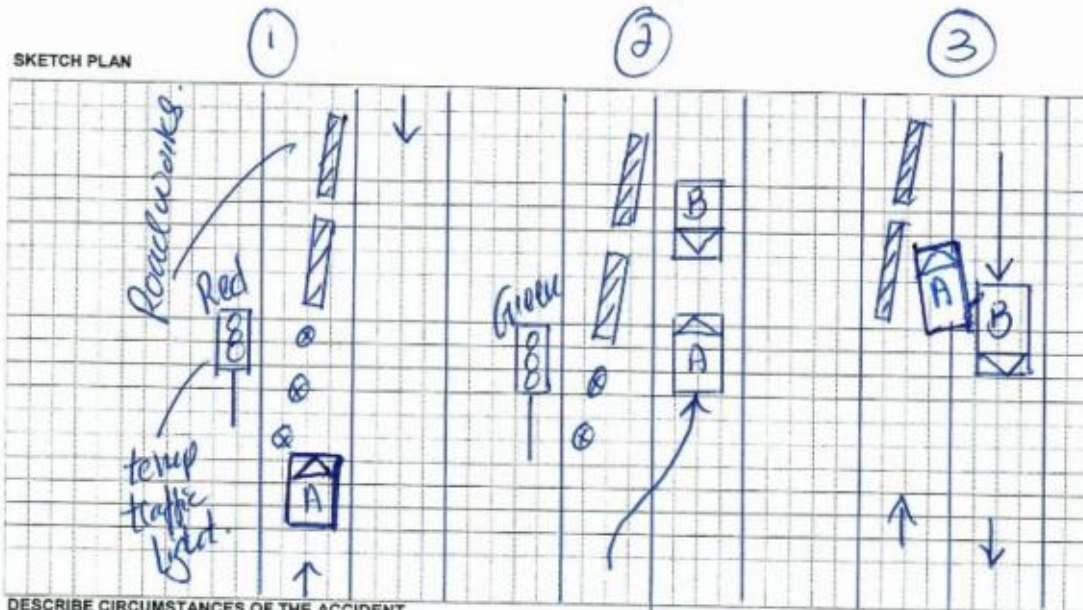
