In the case of stolen vehicle, User will bear the excess amount after making claims from the insurance company. 

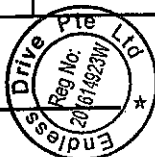
