



Brief Details.

On 03/11/2018, at about 1630hrs, I was driving my lorry (GY3622X) along BKE and was turning into the filter lane to KJE. While I was inside the bend, there was an impact coming from my right rear area and also my front driver door area. Immediately, I stopped my vehicle along the side and alighted from my vehicle to make a check. I discovered there was another vehicle (SKE6394S) had skidded and collided onto my rear right vehicle portion and my front right driver door portion. The vehicle also skidded until the position was facing against the flow of traffic. In addition, the other vehicle's front bumper was stuck onto the bottom right portion and I managed to take it out. I also noticed my rear signal light was damage and the rear portion of my vehicle have dent mark. There were also scratch marks and dent mark on the front right driver door area.

I checked with the driver who informed he was not injured and told me to report it to my insurance. We exchange both of our particulars and took photo of the scene before I left the accident location.

At that point of time. I felt slight pain on my back but I drove off first as the traffic started to congest. Shortly later, I received a call from one caller who identified himself as traffic police, asked for my vehicle number and advised me to lodge a traffic police report regarding this matter. On 04/11/2018, I went to seek medical treatment and was given 3 days of outpatient leave. I wish to state that my vehicle does not have any in-built camera.


