



 - (iv) administering my claims (including the mailing of correspondence, statements, invoices, reports or notices to me, which could involve disclosure of certain personal data about me to bring about delivery of the same as well as on the external cover of envelopes/mail packages); and/or
 - (v) complying with applicable law in administering, processing, handling and/or dealing with my claims.(collectively the "Purposes")




SKETCH PLAN

I was travelling along Singapore Customs towards Malaysia. Suddenly, Vehicle B dashed out and hit onto my vehicle.



