I WAS TRAVELLING ALONG UPPER THOMSON ROAD TOWARDS YIO CHU KANG ROAD WITH ONE PASSENGER (MALE CAUCASIAN) ON BOARD. 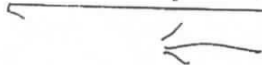
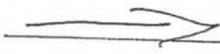
