

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Vehicle No: SJM 9953D (China)
Date & Time: 08/11/18 @ 0540 (Monday)
As I check there were no vehicles on the left, as such I steer to the left lane to exit to T3. Out of a sudden I felt a sudden impact and realised motor taxi SHD 315B who was behind of my vehicle steered into the same lane as well and his vehicle front RH portion had collided into my vehicle rear LH portion. The impact indirectly caused me not able to control with my steering (due to the sudden shock) and my vehicle front had collided onto the side divider/concrete wall.

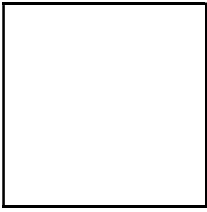
