

We refer to the above matter.

Third party reported that he was driving straight on lane 1. Suddenly our insured had hit onto third party taxi's left side portion.

Our insured rider reported that he was riding along PIE towards Changi on the second lane, when a car in front of him jammed brake. Our rider braked but due to the wet surface, insured rider self-skid and fell to the right. Insured rider mentioned that no contact with third party taxi.

We attached here with a copy of video footage from third party for your easy reference (video will be sent in 3 separate email due to file size limit).

Based on third party video footage, we are of the view that our insured motorbike had collided onto third party taxi as there is a jerk on third party taxi.
