

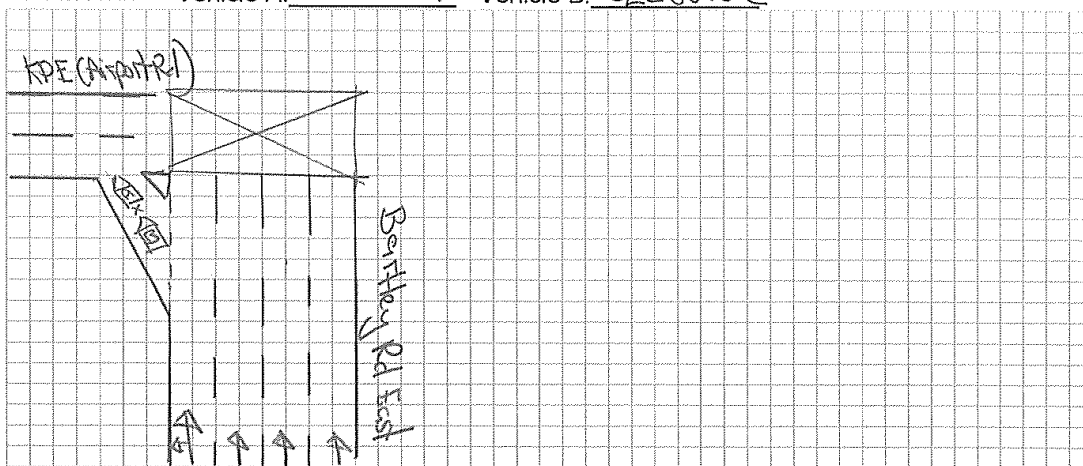

Limitations As To Use
