

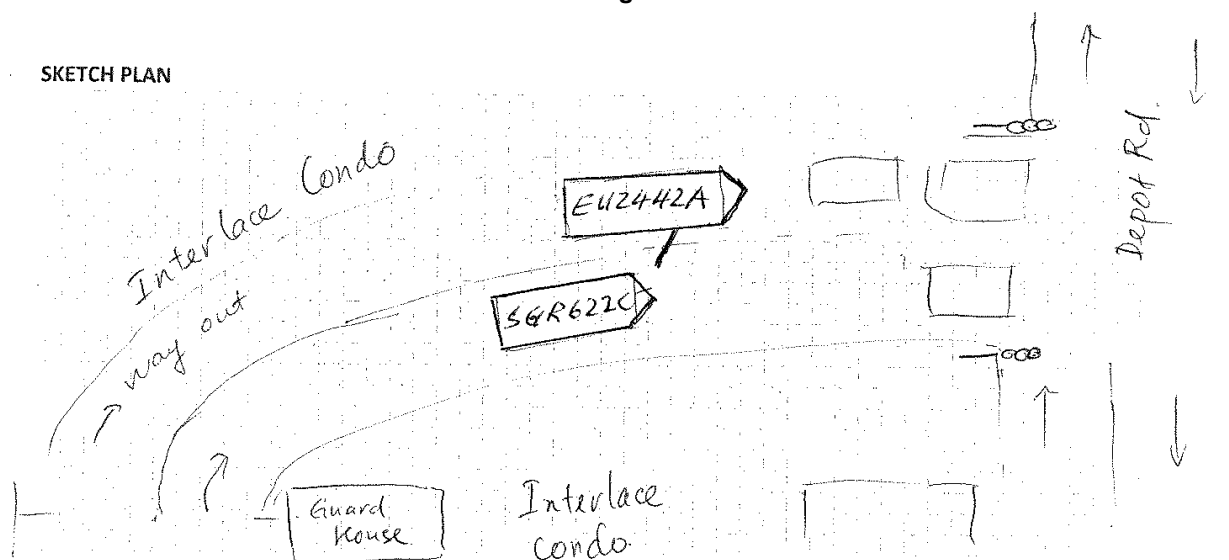

The accident took place when I just passed the Security Guard House about 10 meters away. I was driving slowly with my 4 years-old son and a helper sitting at the back of the passenger seats (I was on the way to sending my boy to his school). The distance of 2 lanes road from the Interlace Condo's Security Guard House to the traffic light (T-Junction between the Interlace roads and Depot Road) is about 20 meters. At that moment, I drove my car with the speed at about 20km/h or less on my lane (right lane), and in front of my car (about 8 meters away from my car, in the same lane) another car was waiting at a stop at the traffic light. There was this white Jaguar (on the left lane) was slightly in front of my car, and his driver's door was about 1.5 to 2 meters in front of my car (there were 2 cars in front of his car were waiting at the traffic light in his lane). As both our cars were still in motion to approaching the traffic light (red light), the white Jaguar's driver suddenly opened his driver's seat door in the middle of the road for no apparent reason and hit my car. This Jaguar's driver did not signal or checking for blind spots while suddenly opened his car door in the middle of the road. This is so unexpected and luckily I was driving slowing at 20km/h or less, I tried very hard to stop my car, but i was too late due to the close distance.

At this juncture, both cars stopped and could not move because the Jaguar's car door was stuck to my car. The Jaguar driver instructed me to reverse my car, but I couldn't reverse. Then he asked me to step down from my car and and let him try to reverse my car. He also unable to

reverse my car. Then he tried to shake his own driver's seat car door violently and eventually managed to release my car from his car door. At that moment, so many cars were building up behind our cars and the Security Guard advice us to move our cars aside immediately to avoid blocking the traffic.

After aligening my car infront of his white Jaguar safely, I went to ask the Jaguar driver, "why you suddenly opened your car door like that in the middle of the road, it is very dangerous"? He mentioned something to me which I had no idea what he was talking about. Then he said "Madam, just give me your ID, and we ask our insurance agents to settle". His lack of apologetic and unusual attitude made me feel so strange. So, I told him: "you should apologise for your fault by causing shocked to my 4 years-old son, myself and my helper who were sitting in the car. Also, causing unneccassary inconveniencies and damange to my new car".

Immediately I advice him that we should wait for the traffic to clear up and reposition our cars at the accidents scene to allow us to take photos of the exact accident scene's position. But he replied, "I cannot do that". The Security Guard also did not allow me to do so, as he afraid we will create traffic jam. Since this white Jaguar car driver do not wish to do that, however I believe all these happenings had already been capture and recorded in my car camera as well as the security camera from InterLace Condo. I am more then willing to provide you with my car camera recorder for your further investigation if you require.
