ACCIDENT INVOLVING VEHICLES GBC 9613H (OI) AND SHC 4712S (TP) ON 08/11/2018

We refer to the above matter.

It was reported that Insured vehicle was changing lane when collided to the TP vehicle.

We had spoken to the Insured Company PIC Mr Alex and was informed of the TP claim. A letter was also sent out to the Insured company to notify TP claim and NCD issues. No feedback received till date.

As such, under MCF and BOLA scenario 15, liability is not to our Insured's favour and we have to settle the claim from the TP vehicle and the damages sustained to TP vehicle were consistent to the nature of the accident.
