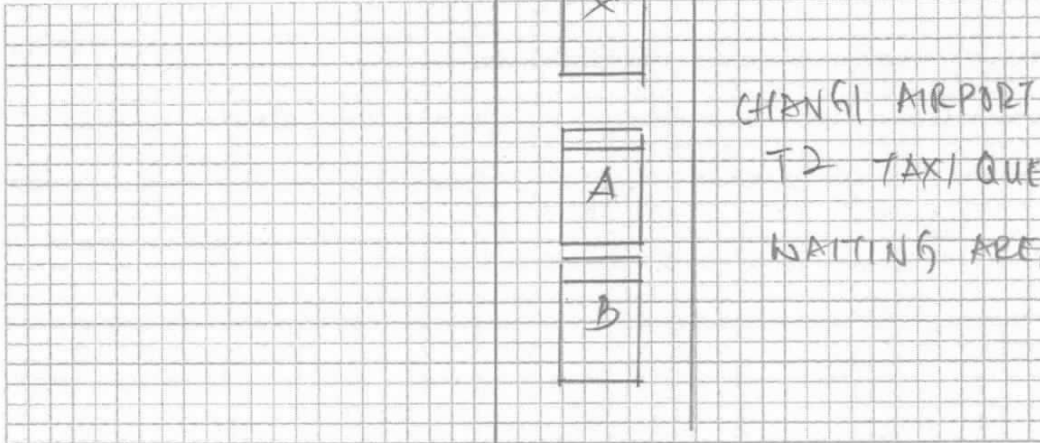

ON 14/11/2018 @ 1410HRS, I WAS DRIVING MY TAXI (SHD 1389 G), TRAVELLING ALONG CHANGI AIRPORT T2 TOWARDS THE TAXI QUEUE/WAITING AREA.

I STOPPED MY TAXI AS VEHICLES AHEAD OF ME STOPPED – HEADING TO THE QUEUE.

WHILE STATIONARY, SUDDENLY I FELT AN IMPACT FROM THE REAR.

WHEN INSPECTED, I DISCOVERED THAT VEHICLE B (SHD 3311 S – COMFORT TAXI) WHICH WAS BEHIND ME, HAD COLLIDED ONTO THE REAR OF MY TAXI.

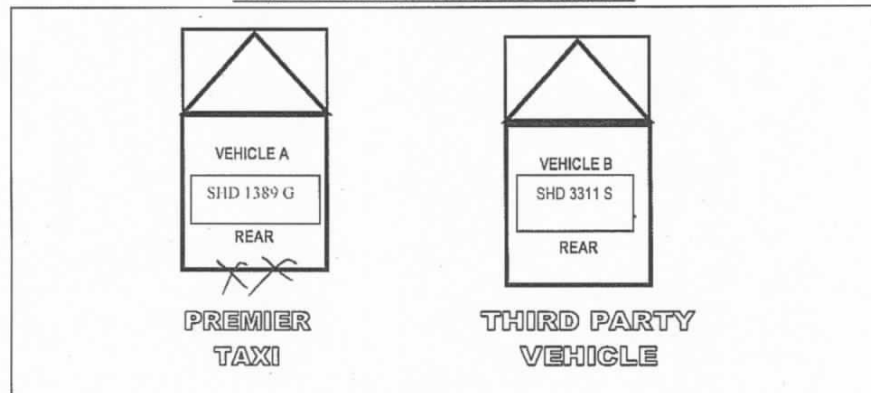

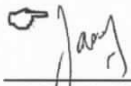
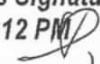
