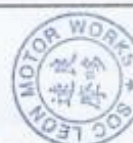

ACCIDENT REPORT

ACCIDENT LOCATED AT BARTLEY ROAD EXIT TO AIRPORT ROAD

On 19th Nov 2018 at 2:10pm, I, Chang Kwok Choy NRIC S6923971D, the driver of vehicle with the car plate number SKA7144L was travelling along Bartley Road East and exiting to Airport Road. I came to halt before the parallel broken white line to give way to traffic on the major road. The Taxi driver, Mr. Tan Boon Seng NRIC S7130369A, the driver of vehicle with the car plate number SHC328U, was at the junction and was moving out of the parallel broken white lines and I started to move forward as the main road is clear from traffic. The Taxi, SHC328U, suddenly jammed his brake and my car SKA7144L collided with the Taxi.
