Brief Details.

On 20/11/2018 at around 1130hrs I was traveling along Yishun Avenue 7 junction of Canberra Dr heading towards Yishun, I was traveling on lane 2. I had just passed the traffic light when one Tipper Lorry which was changing lane from the lane 3 hit upon the rear right of my vehicle.

My vehicle span and now the right side of my vehicle was facing the lorry, The lorry continue to drag my vehicle for another 100 Meter before coming to a stop despite me using my horn while I was being dragged. When both the vehicles came to a stop I managed to climb out of my vehicle through the passenger side of my vehicle after informing my sister in law to exit the vehicle.

I was sitting at the side of the road as I was dazzled by the accident together with my sister in law the other driver came forward and informed that he thought his tire had busted and did not see that he had stuck my vehicle. I was there by the side of the road until the ambulance arrived and before I left the scene in the ambulance the responding traffic police managed to ask some questions and passed me the report number to make a report.

I was then sent to Khoo Teck Puat Hospital and got 2 days MC from the accident. I suffered a sprain in my left hand and neck due to the accident and also some abrasions from the shattered glass on my left foot, at this time I do not know the cost to repair my vehicle. This is the first time that such a thing had happened to me. That is all.
