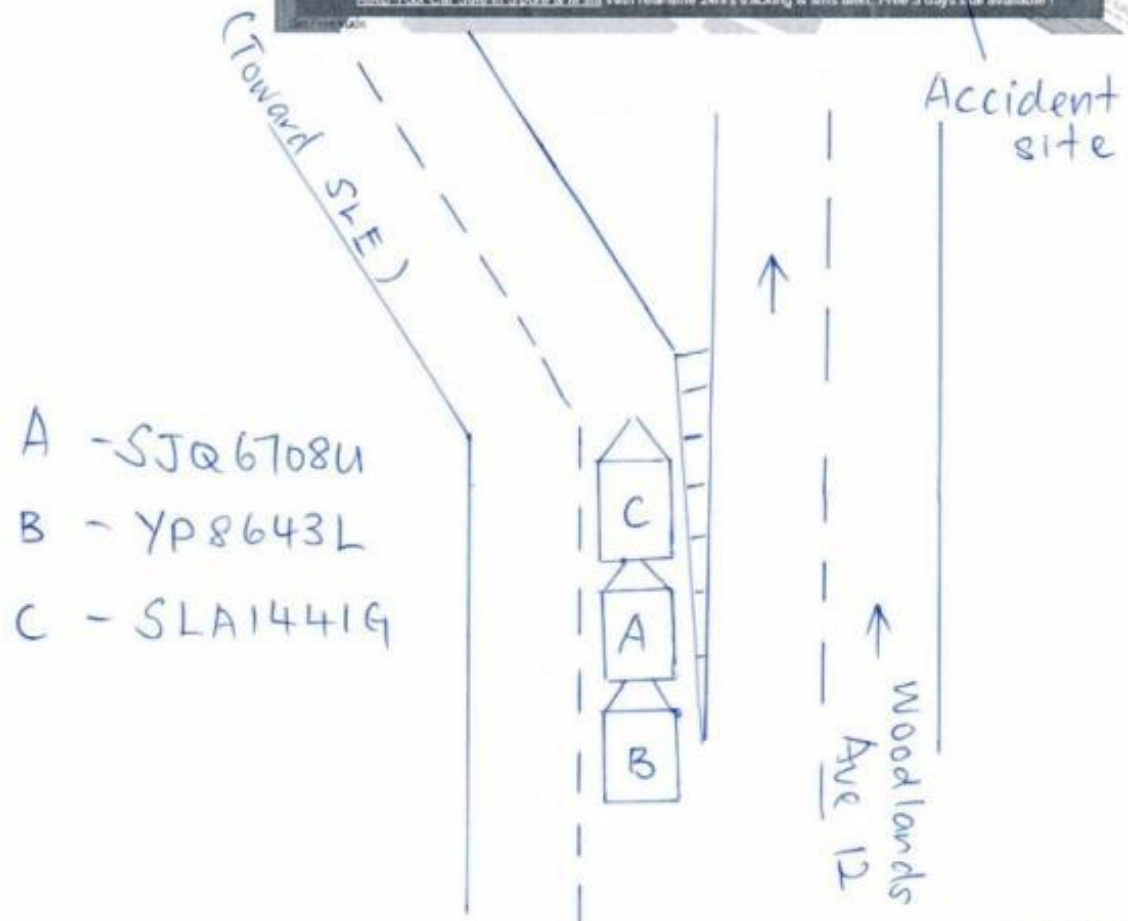
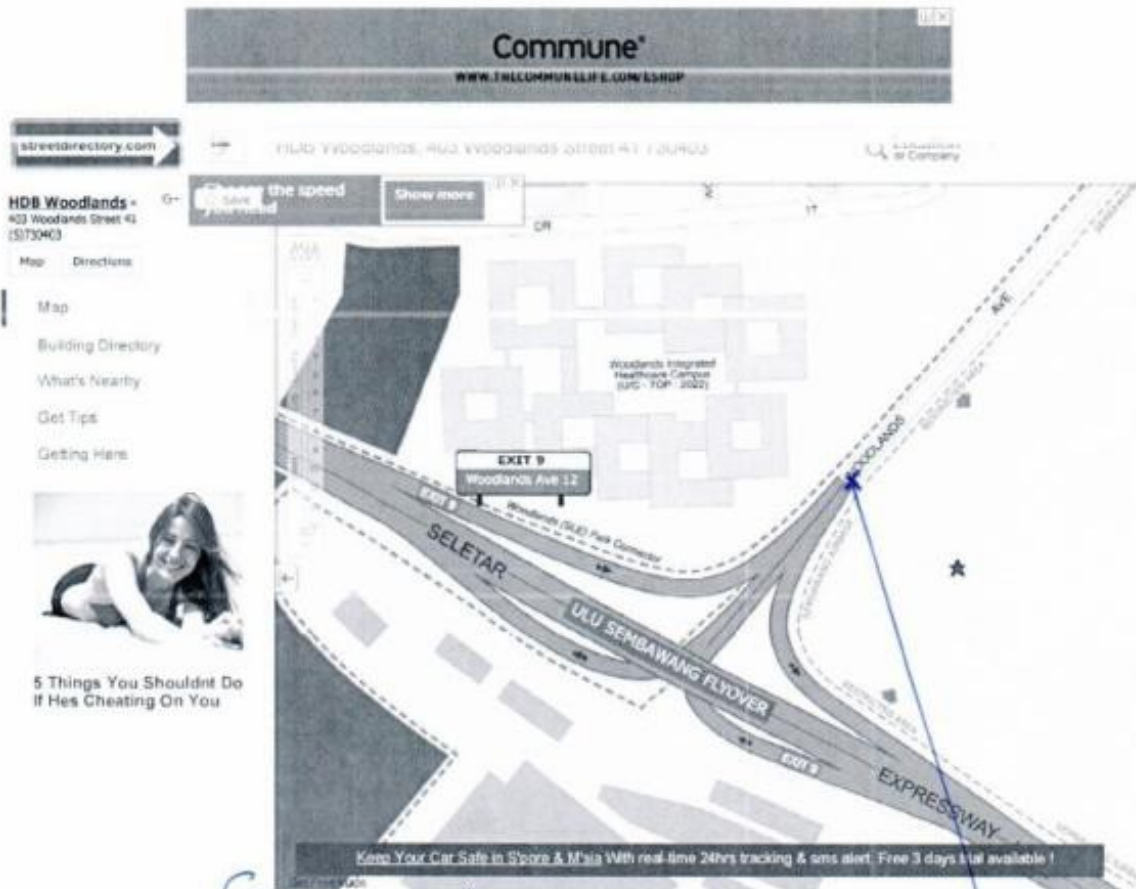

Accident Sketch Plan


