## DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 3/11/18 at around 7.45pm I was the driver of vehicle SKH6572D Toyota Alphard. My vehicle was parked in a parking lot along Queen Street near Singapore Johor Bus Terminal. I was sitting in the vehicle all along as I was waiting for a phone call, a few minutes later a lorry G8E 7254m driven by MR Tan Tian Koon approached and tried to parallel park into an empty parking lot behind my vehicle. While he was reversing into the empty lot, his vehicle right side mirror accidentally hit onto my vehicle left body. I immediately signaled to him that he had knock onto my vehicle, we both alighted from our vehicles to inspect the damages. There was a small dent on the left side on my vehicle near left rear signal lights. Mr Tan Tian Koon admitted that he was at fault while reversing his vehicle. As the damage was very minimum, Mr Tan offered to compensate me for the dent. He passed me \$25 which I accepted for the compensation and we both treated this incident privately settled and case closed.




