Brief Details.

On 19 November 2018 at about 215pm, I was driving my white Nissan Note bearing registration number SMD4777R along Moulmein road towards Balestier. I am staying at 115 Shrewsbury road and I was heading home at that time. Upon reaching the junction of Moulmein road and Shrewsbury road, I stop my car before turning right into the road where I lived. There was a yellow box at the junction of Moulmein road and Shrewsbury road. At the point of time, there was a queue of vehicles along the extreme right lane of the 3 lane road along Moulmein road towards Thomson.

The yellow box junction was clear thus I inched my car forward to turn right into Shrewsbury road. As I was inching my car slowly to turn right as the traffic was uncertain, out of a sudden one motorbike appeared and collided into the left front side of my car. I did not notice the motorbike coming from the 1st lane. The Impact left the driver in pain as he stepped down from his motorbike. I immediately called the ambulance and police for assistance. The registration number of the vehicle is FBM1958M.

The rider was treated by paramedics and later conveyed to the hospital. The traffic police who arrived at the scene also interviewed me with regard to the accident before leaving with my SD card which captured the incident. The left front portion of my vehicle was slightly damaged however my car is still able to move. I did not suffer from any injuries.

Continuation of CSF For NP168

Brief Facts.

On 19th November 2018 around 2:15pm, I am driving a Nissan Note along Moulmein Road, registration number SMD4777R towards my home at 115 Shrewsbury Road.

Moulmein Road has 2 directions, each composing of 3 lanes. I will refer to the lanes of Moulmein Road towards Thomson as lanes 1, 2 and 3 (refer to sketch). I was driving on Moulmein road towards Balestier, with the intention of taking the side turn into Shrewsbury Road. This side turn crosses the Moulmein Road direction towards Thomson Road and has a Yellow Box.

To note is that for the direction towards Thomson, Lane 1 has a side turn into Novena Square. Thus, it is common for vehicles to queue for that turning at lane 1, often going past the yellow box.

At around 2:15pm, there was a queue for the turning towards Novena Square in lane 1. The queueing cars have left the yellow box empty. First, I stopped the car before turning to ensure the traffic allowed me to enter the yellow box. I notice they did. Then, exercising yellow box rules, I entered the yellow box, cautiously inching forward. As I inched forward, I saw the a motorcycle travelling quickly along Lane 1, alongside the queueing cars. I immediately stopped the vehicle, but the motorcycle did not slow down. The motorcycle intruded into yellow box territory and rammed the side of the car.

The motorcycle registration number is FBM1958M. I left the car to take pictures of the situation and called the ambulance and police. The motorcyclist experienced pain. The traffic police who arrived took down my contact details and obtained the SD card of my in-car camera.

The left front portion of the car chassis was slightly damaged. I did not sustain any injuries.
