CONTINUATION OF REPORT

Brief Details.

On 09/11/2018 at 1000hrs, I was driving my vehicle, SFV1996H, along PIE towards Changi. I was driving on lane 1. It was drizzling and the road was wet. The traffic was heavy and slow moving. Then before Eng Neo Avenue exit, there was cars in front of me at lane 1 and lane 2. A motorcycle, FBD5185Y, which was travelling in between lane 1 and lane 2 went past my car. The motorcycle was in front of me for quite sometime as the cars in front of it were to close to each other and the motorcycle could not squeeze in. Then the car in front of me jam braked. The motorcycle also jam braked and it caused the motorcycle to skid. I applied the brake immediately and managed to stop without hitting the motorcycle which was on the road. I continued pressing the brake. However, a taxi behind my car did not stop on time and hit onto my car causing my car to surge forward and hit onto the motorcycle.

No serious injuries at the point of time. No Traffic Police and ambulance were at scene. The rider acknowledged that my car had stopped about a meter from his motorcycle before the taxi hit onto my car. Subsequently, I felt pain on the back of the neck and went to Mount Alvernia Hospital and was given 5 days medical leave.
