The incident happened at approximately at 5.55pm. It was raining heavily. I was driving along Sengkang East Road heading towards airport. My vehicle was on Lane 2-going straight lane for all vehicles. There was a long line of vehicles on Lane 1 waiting to turn right onto Anchorvale Street. As I was approaching the intersection, vehicle no. SKB 2249X suddenly turned out from the line of waiting vehicles, encroaching into my lane without ample warning. As a result, vehicle no. SKB 2249X collided into the front right portion of my vehicle while filtering out. Due to the sudden impact, I swerved my vehicle to the left and came into contact with another passing vehicle no. SGL 5011P which was driving on Lane 3. No one suffered any injuries.




