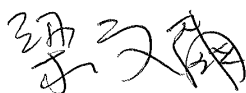

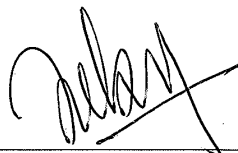

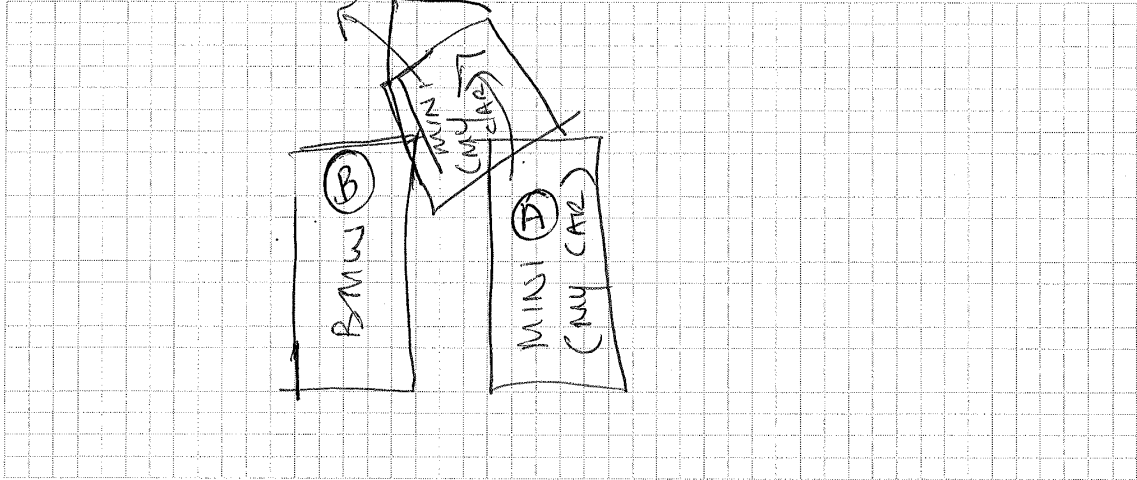

SKETCH PLAN

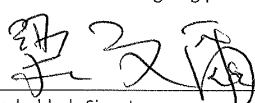
