

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I WAS TRAVELLING ALONG BOON TECK ROAD TOWARDS SUN RAMA RAMA DIRECTION, IT IS A DOUBLE LANE, DOUBLE CARRIAGE WAY.
WHILE DRIVING FORWARD, AS APPROACHING 42 BOON TECK ROAD I SAW A VEHICLE STOPPED AT THE OPPOSITE DIRECTION, AS IT WAS STATIONARY I PROCEEDED ON TO PROCEED AHEAD, WHEN SUDDENLY THE VEHICLE START REVERSING, I IMMEDIATELY STOPPED MY VEHICLE, NEVERTHELESS AS THE VEHICLE (SKJ 6545 Y) MAKING A REVERSE INTO 42 BOON TECK ROAD THE LEFT FRONT PORTION OF THE VEHICLE HIT ONTO THE FRONT RIGHT PORTION OF MY VEHICLE, EVEN THOUGH I HORNED TO WARN THE DRIVER.
BLIGHTED FROM MY VEHICLE AND REALIZED IT WAS A VEHICLE WITH CARPLATE (SKJ 6545 Y) THAT COLLIDED TO THE FRONT RIGHT PORTION OF MY VEHICLE WHEN I WAS IN A STATIONARY POSITION.
