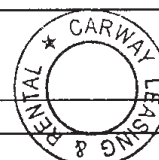

Brief Details.

On the 24/11/18, I woke up to a stiff neck and gotten a 3 days of MC from it.


