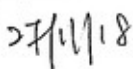

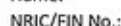

As a bus was approaching, it honned at SLG 6702 M. Reacting to this the driver reversed and hit into my car. The exit at Tanistock Avenue was ~~inclined~~ ^{an upslope} towards the main road.

Upon impact, the driver of SLG 6702 M exited the vehicle, inspected the damaged before proceeding to make the turn towards Ang Mo Kio Ave 3. I ~~did~~ was not given the opportunity to take pictures at the exact scene. The driver refused to admit responsibility and pushed the blame to me.
