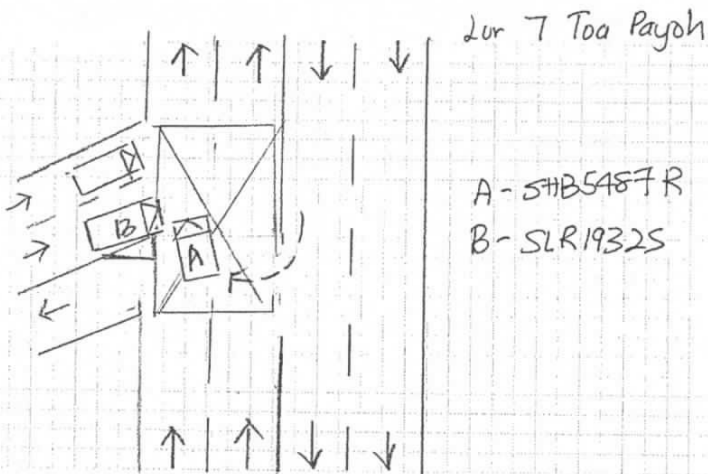

SKETCH PLAN

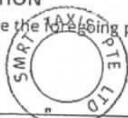
