

The above mentioned patient was seen at Singapore General Hospital (SGH) Department of Emergency Medicine (DEM) on 5th April at 21:10 hours by me. He was a motorcycle rider who was turning right at 10-20km/h when he was contacted by a car turning right as well. He lost balance and fell to his left side. He came to the Emergency Department complaining of left hip and knee pain.

- On examination, patient was conscious, alert and hemodynamically stable. There was full range of motion of his left hip and knee although it was painful while ranging. There were no gross joint effusions noted. There were abrasions noted over the left flank and left knee anterolaterally.
