SKETCH PLAN

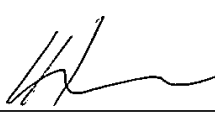

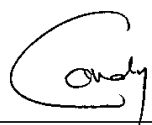
I understand, acknowledge, agree and consent that:

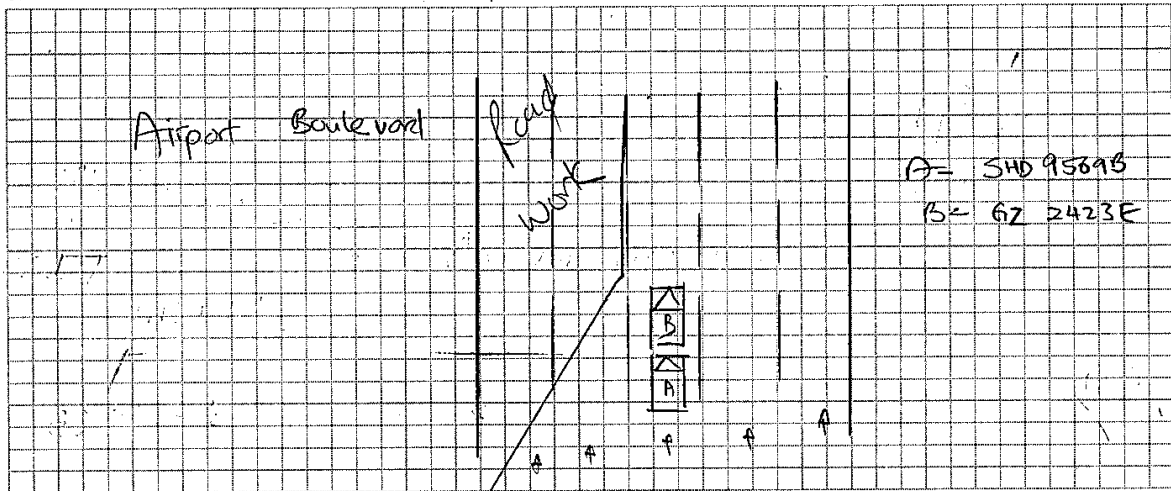
