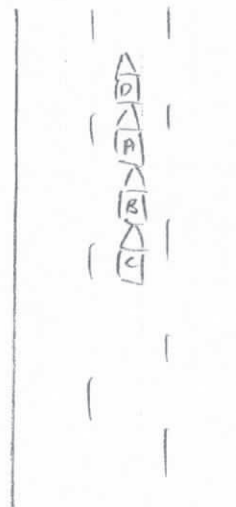

- (D) - SCT 44B

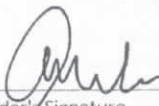


DESCRIBE CIRCUMSTANCES OF THE ACCIDENT
