

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving my car (SGG 81914) along AYE and exiting at Exit 9 to Clementi Road on 04/12/2018 at approximately 12:36pm. Upon entering the exit side road, suddenly I noticed that the road in front of my car was blocked by several traffic cones along the side of the right kerb (apparently, there was some tree cutting exercise ahead). Consequently, I have no choice but to bring my car to an eventual stop. Upon complete stop, suddenly I heard a low "thump" sound and realised that a motorbike knocked into the back of my car. Immediately, I alighted from the car and approached the motorbike rider. Based on my observation and upon his confirmation, he was not injured. However, upon closer observation, it was noted that the collision has caused some scratch marks on the left side of the back bumper. Both the rider and myself exchanged personal particulars for further follow-up. There being nothing further to report.
