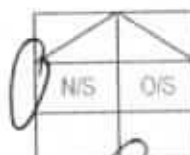

**Brief Details.**

I am working for Comfort Delgo.

On 16/11/2018 at about 0629hrs, I was driving my vehicle bearing registration plate SHC110SP along Rangoon Road towards CTE and there is one passenger in my vehicle. I was approaching the sliproad stop line to CTE as such I slowed down my vehicle. Suddenly a motorcycle bearing vehicle number FBF8203Z hit onto my vehicle's left side mirror and fell to the ground. I got out from my vehicle and spotted the motorcyclist and his pillion on the road and was shouting in pain. As such my passenger called for ambulance. After which I spotted another motorcycle bearing registration plate number FBM2735H which was about 15metre behind my vehicle and the motorcycle was also observed to be lying side way onto the road however I have no idea what happened to the motorcyclist.

Ambulance arrived at scene and the rider and pillion of FBF8203Z was conveyed to TTSH. Traffic police also arrived at scene and managed to obtain the particulars of all parties. There is in-car camera in my vehicle and the memory card was handed over to the police. There is one passenger in my vehicle and he witness the whole incident however I do not have his particulars. I did not suffer any injury. My vehicle left side mirror came off after the accident however I managed to attach it back.

I wish to state that I do not have particulars of any involved parties.

**Brief Details.**

I am working for Comfort Delgo.

On 16/11/2018 at about 0629hrs, I was driving my vehicle bearing registration plate SHC1105P along Rangoon Road towards CTE and there is one passenger in my vehicle. I was approaching the sliproad stop line to CTE as such I slowed down my vehicle. Suddenly a motorcycle bearing vehicle number FBF8203Z hit onto my vehicle's left side mirror and fell to the ground. I got out from my vehicle and spotted the motorcyclist and his pillion on the road and was shouting in pain. As such my passenger called for ambulance.
