

Brief Details.

I am working for Comfort Delgo.

On 16/11/2018 at about 0629hrs, I was driving my vehicle bearing registration plate SHC1105P along Rangoon Road towards CTE and there is one passenger in my vehicle. 

Brief Details.

I am working for Comfort Delgo.




