Brief Details.

On 16/11/2018 at 0630hrs, I was riding my motorcycle FBF8203Z along CTE towards City with my daughter Farah Kamilah Binte Sarip Udin, S9224895Z as a pillion. The weather was clear and the road was dry. As I was at near the exit to balestier. I was riding along lane 2 at a constant speed. Out of sudden, I felt an strong impact coming from the rear of my motorcycle and cause motorcycle to spin and hit onto the another motorcycle on the lane 1. My daughter and I fall to the ground.

After the incident, I managed to stand up and make a check on my daughter. I am not really sure how the accident took place. I make a check with the other rider Hafiz and he informed that the taxi SHC1105P had hit onto my back to cause the accident. My daughter and I was conveyed to TTSH by ambulance. I had suffered abrasion on my both hands, left arm and both legs. I have stitches on my right hand. I was instructed to lodge a traffic accident report by the IO in charge,
