1. Driver, hirer or lessee of vehicle from our company whose age is below 26 years and driving license is less than two years will have to pay an excess of SGD4,000 plus GST at SGD280, total SGD4,280 for own damages and/or SGD4,000 plus GST at 280, total SGD for third party claim.
2. Driver, hirer or lessee of vehicle from our company whose age is 26 years or above and driving license is more than two years will have to pay an excess of SGD2,000 plus GST at SGD140, total SGD2,140 for own damages and/or SGD2,000 plus GST at SGD140, total SGD2,140 for third party claim.
3. In an event of an accident where the driver may deem to be at fault, the driver will be required to make payment of the above mentioned excess. Should the driver, hirer or lessee fail to settle immediately, our company will take possession of the vehicle or other vehicle/s that are leased from our company and offset the deposit and take legal action to recover the above-mentioned excess and repair bill.
4. Only the registered Lessee is allowed to operate the vehicle. For vehicle operated other than the registered Lessee, the registered Lessee will have to take full responsibility for any damages to the vehicle.
5. For any Legal cost will be bear by the Lessee or Driver without prejudice.
6. For any unreported accident, the Lessee will have to take full responsibility for any cost pertaining to the accident cost.
7. The lessee will be required to send the vehicle for LTA mandatory inspections upon request by the Company and will be responsible for any fine imposed on the company should the Lessee fail to do so.
8. For monthly contract, the Lessee will be contracted for a minimum period of 3 months and required to advise the termination or renewal of the contract one month in advance. The Company reserves the rights to take possession of the vehicle should the Lessee default payment be more than 3 days.
9. For weekly contract, the Lessee will be contracted for a minimum period of one month and provide a minimum of one week notice for termination of contract. Default of payment for more than a week will allow the Company the rights to take possession of the vehicle.
10. The Lessee shall agree to take full responsibility for the charges of the rental and repair costs should there be due negligence in taking care of the car.
11. The above-mentioned terms and conditions was explained in language understood by the Lessee. Please append your signature to show you have understood the above mentioned insurance policy.

The Lessee further agrees to their obligation hereunder shall be binding and fully understands the content of this vehicle Leasing Agreement and its clauses without prejudice and reservation.
