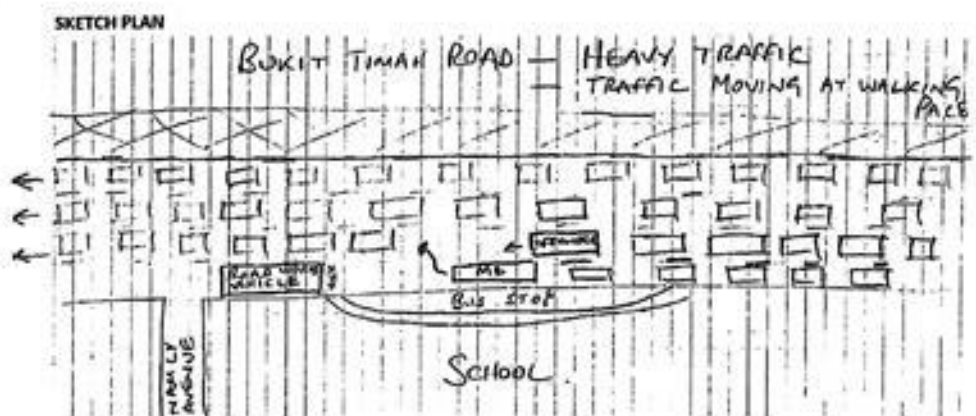

Subject: DETAILS OF THE INCIDENT

At approximately 12.15pm on 17 November 2018, I was driving my elderly mother (74) and two daughters (aged 6 and 1) home along Bukit Timah Road in heavy traffic due to road works. The offending vehicle was occupied by the driver, an adult female passenger and a child. Traffic was, at the time of the incident, moving very slowly at around walking pace. I was in the inside lane of the road (ie on the left), with cars ahead of me and road construction vehicles directly ahead of them. The road construction vehicles were blocking my lane ahead and there were signs with arrows indicating a lane closure and pointing to the right.

I and the other traffic ahead, next to and behind me were moving at less than 5 to 10kph. I put my indicator on to move over into the right lane, waited for cars in the lane next to me to allow sufficient pace to change lane, all while checking my mirrors. My lane eventually came to an end just before the road construction vehicles. There was a more than sufficient gap in the traffic in the lane to my right to move into. The offending driver had left a gap, I had presumed for me to move into. I was 80 per cent of the way into the new lane when the offending driver accelerated quickly to block me from joining my lane – and, I would suggest, intentionally, drove his car into mine, scraping my rear right hand side ("RHS") wheel and the RHS rear wheel arch. Obviously, hitting me on that part of my car when we were barely moving at a walking pace, and I was almost completely into the lane and about to come to a standstill because of traffic ahead of me in the new lane, his actions were very surprising. At worst, this was a case of road rage type behavior on the part of the offending driver. At the least, it was extremely inconsiderate and unsafe driving. I am not sure why he acted so aggressively or why he was so angry. Perhaps the tension of being in a traffic jam got the better of him.

Upon being rammed into by the offending driver, I immediately pulled back into the blocked left lane, again just ahead the road construction vehicles and signs, so as not to add to the already heavy congestion. The offending driver pulled over just ahead of me and we exchanged details.

No-one was hurt fortunately and the damage to both cars appeared to be relatively minor. I did not intend involving the police or, despite the dangerous nature of the offending driver's driving, reporting him to the police. But, I did suggest to the other driver that he should keep his cool on the road and that had we been travelling at speed, his actions could have caused far greater damage to our vehicles or, God forbid, injury to the occupants of our cars. No words were exchanged. I was pressed for time, as I had to attend my daughter's birthday party. In hindsight, had I have had more time, and had I have known the full cost of the damage caused to my vehicle, I might have been more inclined to file a police report.

I have photos of the damage to both vehicles and the traffic and road construction vehicle and would be happy to provide them.
