While travelling straight along Tampines Ave 9 on the left most lane of 2 lanes, a pte car (SLE9842J) which was on the right lane, overtook my bus. Traffic was heavy and my bus was moving very slowly and i kept a safe distance with the vehicle in front. The pte car tried to overtake and squeeze in the gap in between my bus and the vehicle in front. I could not stop on time hence collided onto the left rear portion of the pte car. Bus sustained right front body scratches. Private car sustained left rear body scratches.
