

Hi Sirs;

May I seek your assistance to perform a detailed mechanical inspection of the 13 vehicles below:

- a) Case IAFP-IB-20181028 Mechanical Inspection of motorcycle FBJ6977L (TP/IP/60763/2018)
- b) Case IAFP-IB-20181028 Mechanical Inspection of motor taxi SHA9324G (TP/IP/60763/2018)

On 27.10.2018 at about 8.27 am, motorcycle was travelling on the lane 1 of 2 lanes road where taxi ahead of him in-between 2 lanes suddenly made an illegal U-turn along Eng Neo Ave X Eng Neo Ave towards Dunearn Road. Motorcycle unable stop in time and collided onto the right side of taxi on the lane 1. Motorcyclists was pronounced dead at the scene.

On 2 October 2018 at 9.08 am, Motorcycle JSJ 8870 and Motorcycle JPH 1866 was travelling on the left lane of 4 lanes when both motorcycles side swiped onto each other causing rider of motorcycle JPH 1866 to be flung to lane 3. As a result the rider was run over by motor bus PC 1706 K travelling on lane 3.On 6 October 2018, the rider of motorcycle JPH 1866 succumbed to his injuries and was pronounced dead at TTSH.

On 18 October 2018 at 5.22 pm, Mini Bus was entering slip road from Boon Lay way into Yuan Ching Road when the mini bus collided onto a female cyclist who was cycling on the driver's right to left. As a result of the accident the cyclist was pronounced dead in NUH the following day.

On 12.10.2018 at about 2.59 pm, motorcycle was travelling along Ubi Ave 3 towards Kaki Bukit where at the signalised junction of Euros Link, he was being hit by a motor car coming from his left side. Motorcyclists was pronounced dead in CGH on the next day.

Case IAFP-IB-20181122 - Mechanical Inspection of Motor Car, SBJ7833R (TP/IP/63425/2018)

On 15.11.2018 at about 9.46 pm, the driver of motor car, SBJ7833R claimed that her brake did not respond when she stepped on the brake pedal. Thus, she could not brake in time and collided onto a pedestrian at a designated signalised pedestrian crossing; along Pasir Panjang Road.

Case IAFP-IB-20181122 - Mechanical Inspection of Mini Bus, PC5941X (TP/IP/64375/2018)

On 21 November 2018 at about 7.07 p.m., the Accused picked up 6 residents from Forestville Condo and he was proceeding to Woodlands MRT to alight them. While exiting from the said condo, the Accused made a right turn from the exit point of the condo. Halfway making the intended right turn, the frontal right portion of the Accused's mini bus collided into the right side of the Deceased while the Deceased was still walking ahead of the Accused's mini bus. Due to the collision, the Deceased sustained traumatic brain injury and he was pronounced dead on the same day at 7.26 p.m. by Paramedic Sergeant Ibnu.

On 20 November 2018 at about 11.28 a.m., the 1st Accused was travelling along AYE towards MCE on the centre of the 3 lanes expressway while the Deceased was riding in front within the same lane. As they were approaching the 5.5 km mark, the 1st Accused overtook the Deceased from his right however, his motor lorry veered back to the left and side-swipe against the Deceased's motorcycle. Deceased lost control of the motorcycle and fell to his left onto the left lane, under the 2nd Accused's motor lorry, in between the front and rear right tyres, and the rear right tyres of the 2nd Accused's motor lorry drove over the Deceased's helmet.
