

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was travelling along Ang Mo Kio Park 2. It was a 2-way lane with lorries and vans parked along the road side, resulting into a congested road. The 2-way lane became very narrow. As I noticed that there was a vehicle at the opposite direction trying to overtake into my lane to pass through, I maintained stationary to give way. After the vehicle successfully passed through, I noticed there was another vehicle (b) behind trying to do the same. As such, I continue to stay stationary. However, vehicle (b) was travelling at a very fast speed and charged towards my direction. While vehicle (b) was approaching my vehicle, he did not slow down or have any intention to brake. This result into vehicle (b) collided heads on onto my vehicle front portion. The impact was so great that it caused my vehicle to thrust backwards at least 5m from my stationary position. The driver of vehicle (b) came down and initiated a private settlement, however I was already feeling unwell after the collision. My vehicle was also badly damaged. To that, I declined and wishes to proceed with the insurance claim. My vehicle was equipped with the dash-camera and it has been handed over to the Traffic Police who was at the scene to facilitate the aftermath.


